



Project Monitoring - WKN as project monitors provide independent and impartial advise to Funder's by utilizing our complete range of skills, experience and expertise in planning, project financial appraisal, cost consultancy, engineering and construction, backed by our thorough understanding of the overall property development process. Risk transparency, control and certainty are at the core of all Funder operations, as project monitors WKN undertake to review and appraise the proposed development to ascertain the nature of the project and to identify and manage risks through all phases of the funding model, that may affect the delivery of the development project. The process is usually completed under two stages:

Initial Project Monitoring: This stage involves among other variables – development budget review, project viability, financial appraisal, cash flow review, statutory compliance, finance/consultancy/construction agreements, programme, and health & safety.

Interim Project Monitoring: This stage involves among other variables - site visits, monitoring programme & contractor performance, quality and Health & Safety, approval of development expenditure, budget cost review, statutory compliance and identifying project changes and project risks / potential risks.

Technical Due Diligence

The technical review process will start with 'Red Flag' reporting based on an initial site visit and documentation review. The 'Red Flag' report will be followed by a 'Draft Full Report' and a 'Final Report'.

Procurement Strategy

WKN provide expert advice to our Clients, in the development of the most suitable, and quite often bespoke in nature, procurement strategy for a project.

The procurement strategy identifies the best way of achieving the completion of a construction project – often taking into account the best value for money over the entire life cycle of the building or facility. The aim of a good procurement strategy is to Achieve the optimum balance of risk, control and funding for a project.











Contract Administration / Employers Representative



WKN have vast experience in contract management across all the main forms of contract, including RIAI, GCCC, FIDIC and NEC. WKN exert a lot of effort in providing Value Add to the process of drafting the Contract Clauses and Obligations, via proactive and regular engagement with the Client's appointed Solicitors during the pre-contract stage.

In conjunction with our Project Management service offering, WKN typically also act as the Employers Representative (ER), which normally includes for the role of Contract Administrator. However, on some project types, where for example, a Client is acquiring residential units from a Developer on a 'turnkey' basis, WKN would only be required to perform a pure ER role, with no Contract Administrator, given WKN are some what 'at arms length' from both the Developer and the appointed Design Team.

Detailed list of (RICS based) Full Employers Representative Role, including for Contract Administration functions, include:

- Administer the Building Contract, including issuing of Instructions
- Obtain advice, from the Developer, and/or their requisite Design Team members or Main Contractor, on quality, cost and programme effects of Variations, prior to the issue of Instructions under the Building Contract. Prepare recommendations for our Client's (Oaklee) approval.
- Issue Change Orders (on our Clients request).
- Monitor progress and assess/issue Extensions of Time (where appropriate) and Practical Completion Certs. Prepare recommendations for Client approval.
- Recommend (and draft) payments certificates, in conjunction with the PQS.

- Obtain monthly progress and quality reports from site staff representing the Main Contractor and the Developer's Professional Team.
- Prepare an ER Monthly Progress Report.
- Attend fortnightly Project/Site
 Meetings as provided under this
 Appointment. Minutes to be by either
 the Project Manager or the Architect.
- Issuing dashboard type fortnightly interim site inspection reports to the Client.
